RE: Appointment of Participants for SEDAR 87 Gulf of Mexico White, Pink, and Brown Shrimp Data Workshop and Assessment Development Team

SEDAR 87 will provide a Research Track assessment of Gulf of Mexico white, pink, and brown shrimp. The Data Workshop will be held September 2023, assessment webinars will tentatively be held between April and July 2024, and the Review Workshop will tentatively be held January 2025.

Each Cooperator is responsible for appointing individuals to participate in all components of the project. As such, I am requesting the appointment of participants for the several of the Panels associated with SEDAR 87, following Gulf of Mexico Council SEDAR procedures.

As this is a Research Track assessment, we need appointments for the Assessment Development Team (ADT). ADT members will participant in all stages of the process. These participants will serve as the decision-making body for this assessment.
