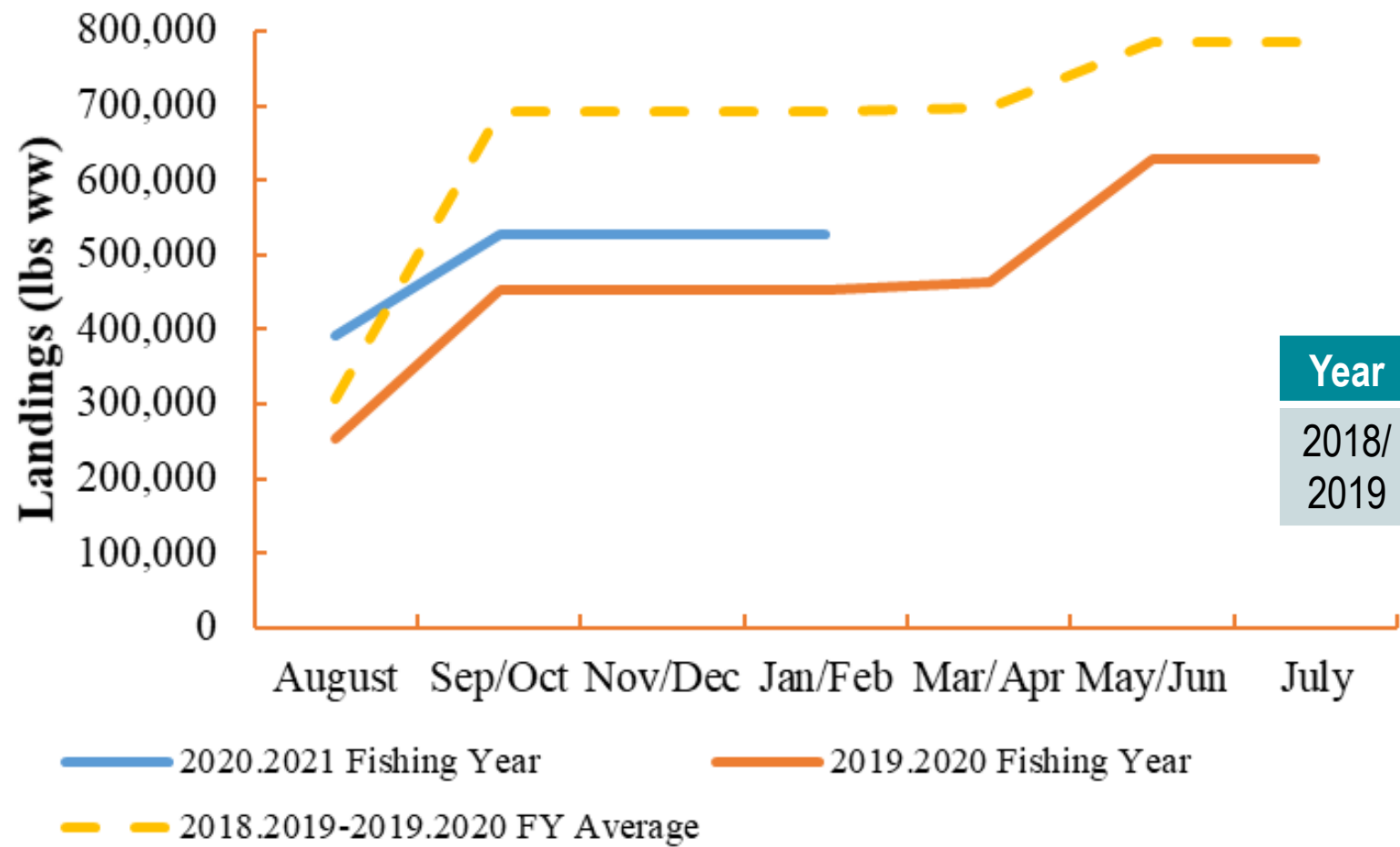
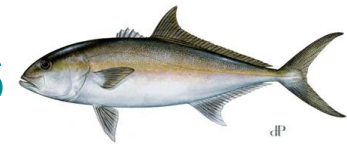


Greater Amberjack Commercial Landings

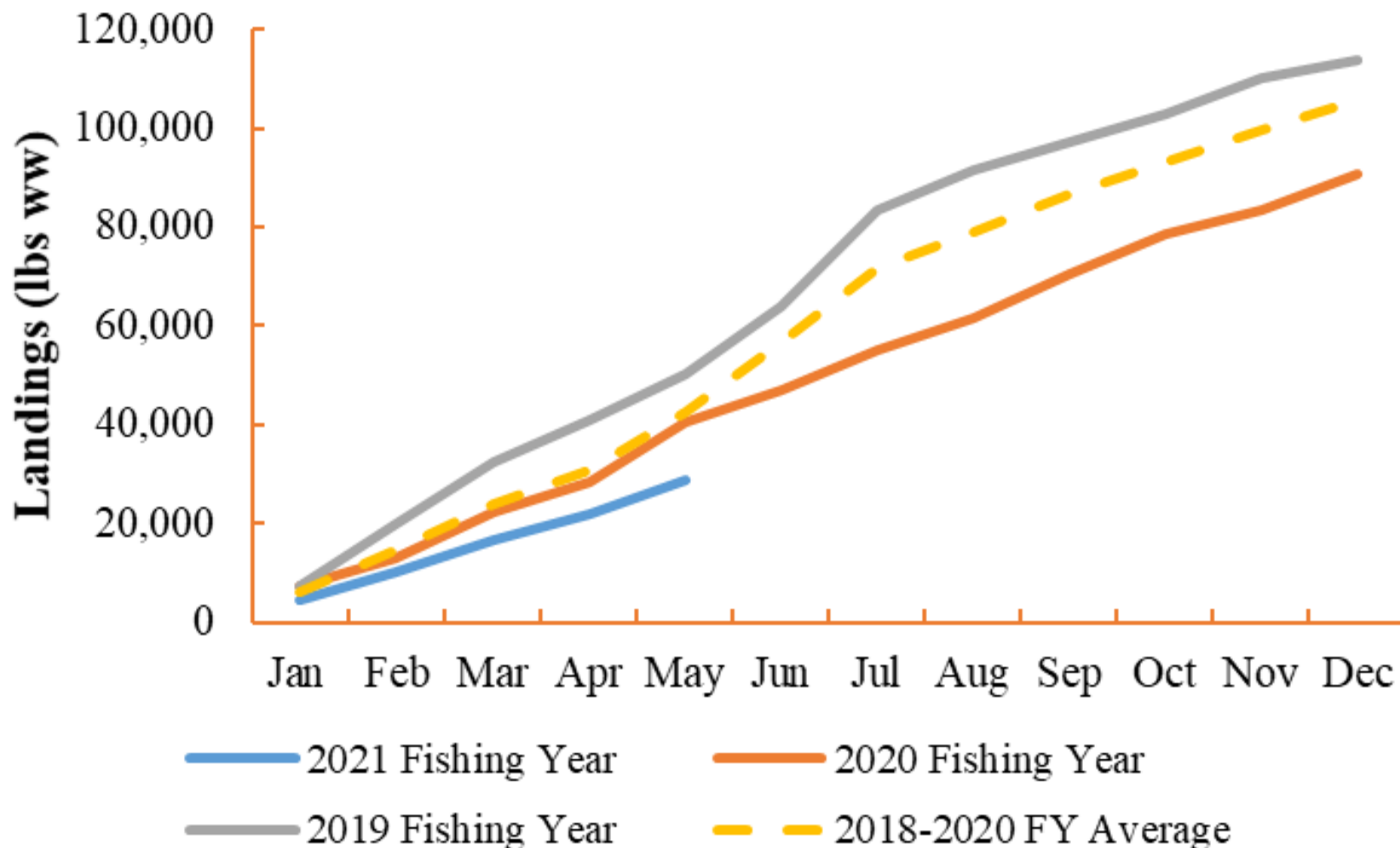
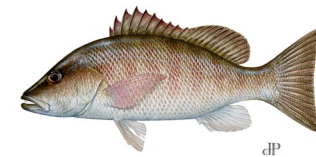
Greater Amberjack Recreational Landings

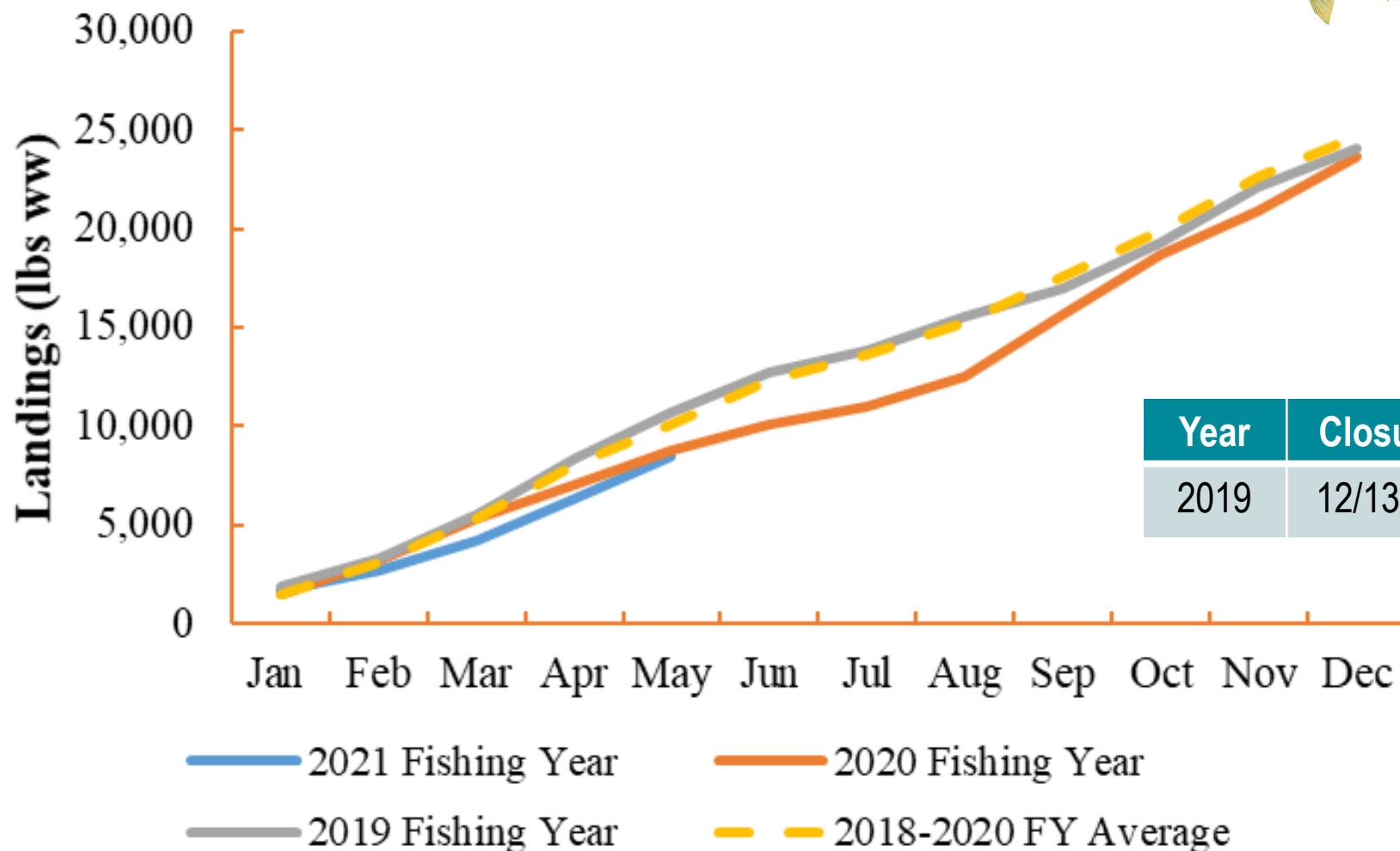

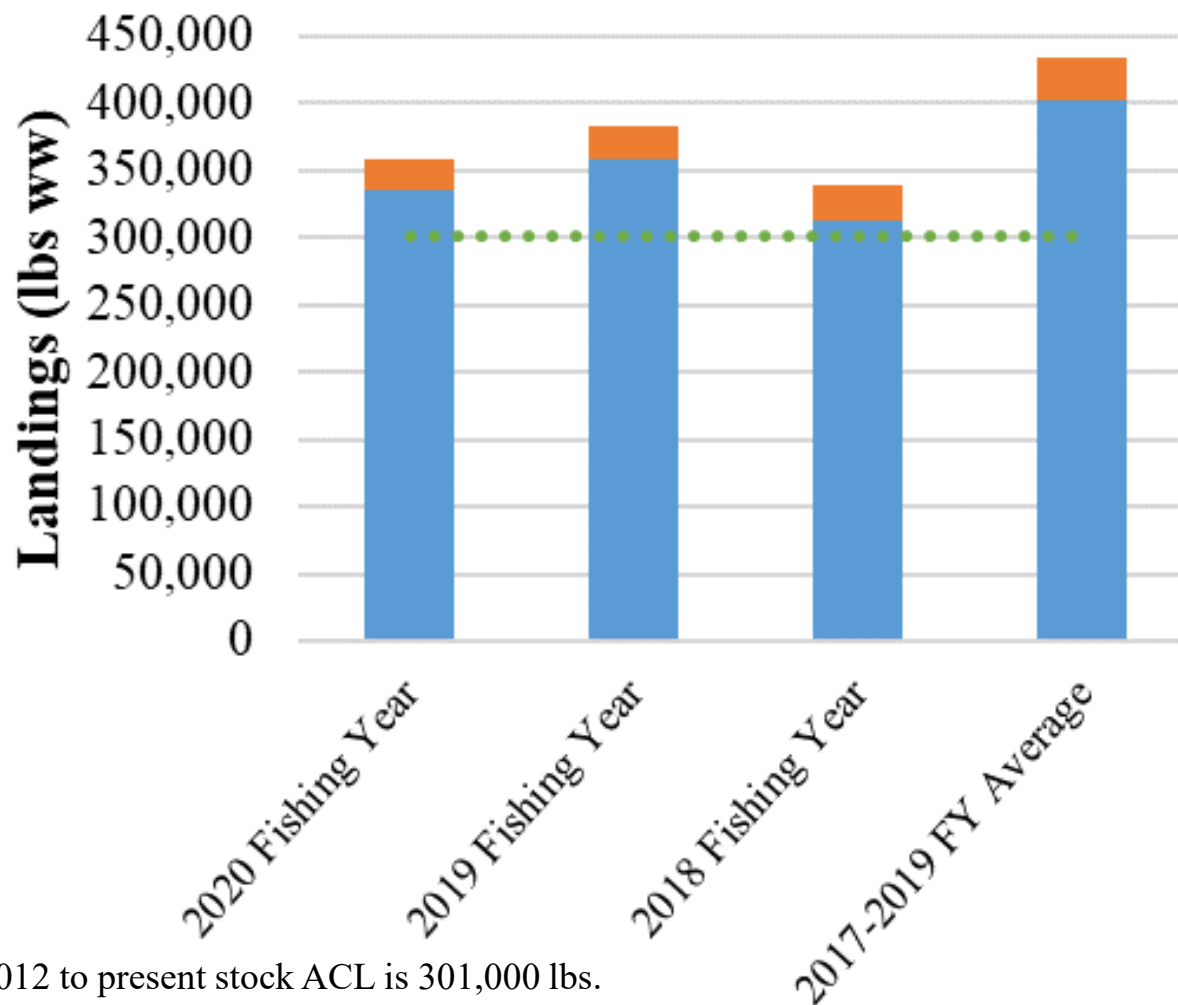

Vermilion Snapper Commercial Landings

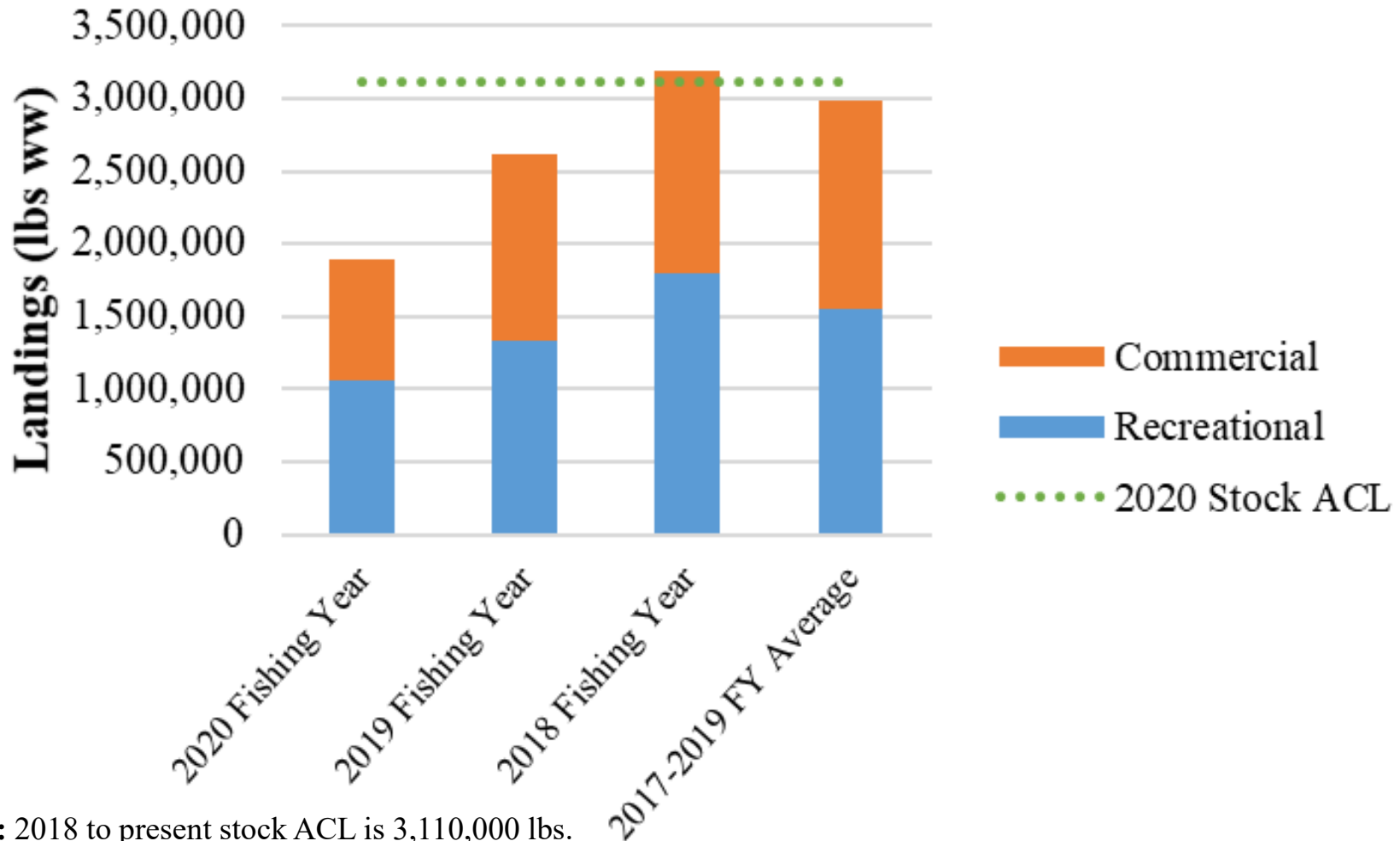

Vermilion Snapper Stock Landings

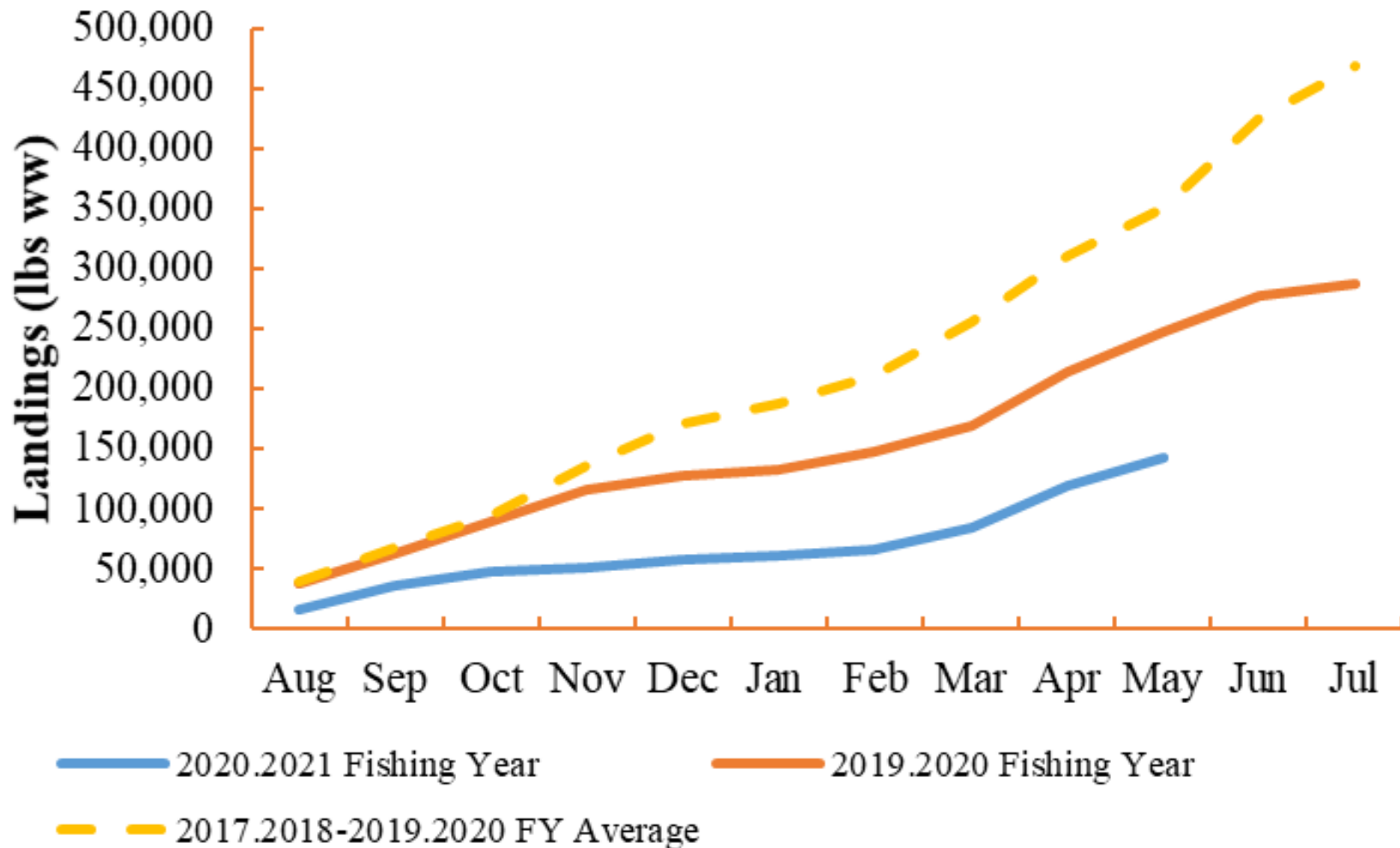

Yellowtail Snapper Commercial Landings



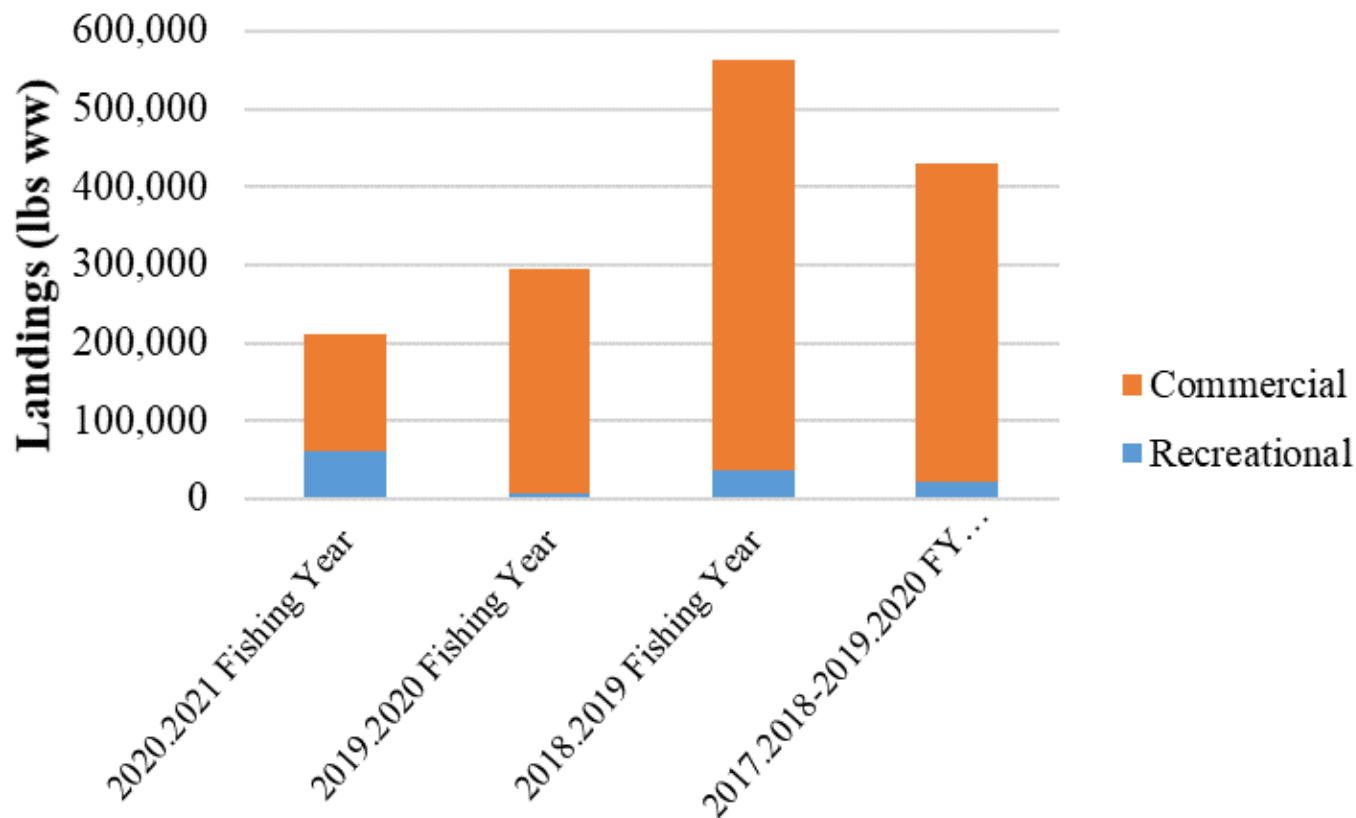
